

Annually IPF processes nearly 1,000 requests for assistance from inmates and their families. We are currently litigating dozens of cases with hundreds more in various stages of review and investigation. Pay for the approximate postage for mailing questionnaires to 25 inmates, which begins the review process	\$25
Defray the costs associated with the screening and evaluation of a potential case	\$100
Cover the cost of an overnight trip for an attorney to travel to let an inmate know we will be taking his case	\$300
Pay for DNA testing on one item (each case requires at least 2 DNA analyses – so our client's DNA can be compared to the evidence)	\$1,000
Pay for three months of transitional services for an exoneree (The State of Florida does not automatically, and may not ever, compensate exonerees)	\$3,000
Pay the approximate costs associated with all necessary DNA testing in a single case to prove factual innocence	\$10,000
Defray all costs associated with pursuing the exoneration of one wrongfully convicted person	\$25,000
